Directions to the Adams House for the CDCC Picnic:

**From the West / North:**

New York State Thruway to Exit 23, then bear right out of the toll booth onto Route 9W south. Follow Route 9W out of Albany (staying left where Route 32 branches off to right) and through Glenmont (about 4.5 miles). Jericho Road is on the right (immediately after the 55 MPH sign); you will also see the sign for the drive-in / ice cream stand. Take the right onto Jericho Road, our house is the 6th house on the right, it's a yellow house.

**From the East / South:**

New York State Thruway to Exit 22, then bear right out of the toll booth onto Route 144 South. Take the 1st right onto Route 396 and follow through the village of Selkirk until you reach the 4-way traffic signal where Route 396 crosses Route 9W. Take a right onto Route 9W and follow for couple of miles. Jericho Road is the next left after the cemetery (on the right) and you will see the sign for the drive-in / ice cream stand. Take the left onto Jericho Road, our house is the 6th house on the right, it's a yellow house.

Look for the CDCC banner and Frank's 37 Chevy parked in the lawn. Feel free to call us 767-0420 or 376-8415 if you're having any trouble finding it. There's plenty of room to park so please bring your cars.

His accomplishments include: drafting the Declaration of Independence, serving as first U.S. Minister of Foreign Affairs, administering the oath of office to George Washington, negotiating the Louisiana Purchase, and developing steamboat technology with Robert Fulton.

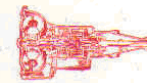
